- 8. Regular Board meeting called to order at 7:07 pm.
- 9. Roll Call: Hafler, King, Tobler, Lula, Giszczak, Jackson and Sherbine.
- 10. Motion by King, 2<sup>nd</sup> by Hafler to approve agenda. Motion passed.
- 11. Motion by Hafler, 2<sup>nd</sup> by Tobler to approve the minutes of August 11, 2009 as amended. Motion passed.
- 12. Public Comments opened at 7:11 pm, closed at 7:11 pm.
- 13. 8/25/09: Motion by Sherbine, 2nd by Giszczak to continue on the current authorized course of action in the matter of W&W Augusta, LLC lawsuit defense, directed by the Board of Trustees and not to enter into settlement negotiations at this time. Roll Call: Aye: Sherbine, Lula, Hafler, King, Giszczak, and Tobler. Nay: Jackson. Motion passed. [Note: there were eight to nine residents at meeting in support of our defense of our Master Plan.]

- 17. Motion by Lula, 2<sup>nd</sup> by King to approve purchase of Rescue 42 Stabilizer Kit. Roll Call: Aye: Hafler, King, Tobler, Lula, Giszczak, Jackson and Sherbine. Nay: None. Motion passed.
- 18. Motion by King, 2<sup>nd</sup> by Hafler to hire three (3) fire fighters, W. Geal III, R. Fox and S. Gootee. Roll Call: Aye: Hafler, King, Tobler, Lula, Giszczak, Jackson and Sherbine. Nay: None. Motion passed.
- 19. Motion by Hafler, to table USDA Pay down for one year. Motion fails for lack of support.

Motion by Giszczak, 2nd by Sherbine (Lula withdrew 2nd) to pay the USDA an additional \$455,000 in Special Assessment payoffs collected from water district customers for a total of \$955,000 representing payoffs collected and not forwarded to the USDA since 1996 and leaving approximately \$525,000 in the Special Assessment bank accounts at this time. Motion by Jackson, 2<sup>nd</sup> by King to table the Special Assessment pay off to the next board meeting for Jackson to get USDA refinancing information and for the Treasurer to forward from MBS (Multi Bank Services) the summary of interest earned over the life of the investment and a summary of the current investment's interest rates and maturity dates (copies of bank statements) by September 3, 2009. - 22. Motion by Hafler to table the Pension Plan Amendment to the next Board meeting. Hafler withdrew motion.
- 23. Motion by Sherbine, 2<sup>nd</sup> by Giszczak to move forward with attorney review of the amended pension plan and the preparation of the IRS determination letter packet with an authorized expense of up to the budgeted \$2,400.00. Motion by Sherbine, 2<sup>nd</sup> by Giszczak to move the pension plan administration responsibility for the IRS determination letter be delegated to the Supervisor as part of his personnel officer responsibilities; friendly amendment Giszczak that responsibilities of personnel officer are according to MCL 42.10(n) which states that the Supervisor is "to assume all the duties and responsibilities as personnel director of all township employees..."
