WHEREAS, the Municipality of Augusta Charter Township hereby requests the Washtenaw County Water Resources Commissioner to make improvements and repairs to the East Branch of Big Marsh Drain for the estimated cost of \$57,000.00 and the Talladay Road Drain for the estimated cost of \$51,000.00; and

WHEREAS, the Municipality of Augusta Charter Township requests the Water Resources Commissioner to use the Township's Surplus Drain Funds in Fund #9077 estimated at \$110,669.35 as of 2/27/2012 to pay for the requested repairs and maintenance to the above drains.

NOW THEREFORE BE IT RESOLVED that the Municipality of Augusta Charter Township hereby requests to the Washtenaw County Water Resources Commissioner to make requested improvements and repairs to the East Branch of Big Marsh and the Talladay Road Drains.

WHEREAS, The Augusta Charter Township Board has reviewed the Township's future projected financial condition, and;

WHEREAS, the Board has reviewed the General Fund Expenses approved by the 2005 Board of Trustees on 9/13/2005 to allocate General Fund Costs to the Fire Millage Fund, the Police Millage Fund and the Utility Proprietary Fund (Exhibit A); and

WHEREAS, the State of Michigan Treasury Department has no laws governing the allocation of indirect costs; and

WHEREAS, the State of Michigan Treasury Department has no guidelines to support the allocation of five percent (5%) of General Fund Costs to the Fire Millage Fund and Police Millage Fund and twenty five percent (25%) to the Utility Proprietary Fund;

NOW, THEREFORE, BE IT RESOLVED that Augusta Charter Township Board of Trustees hereby adopts the Resolution to Rescind General Fund Overhead Cost Allocation Revenue effective April 1, 2012. Roll Call: Aye: Giszczak, Shelby, Tobler, Hafler, King, Lula and Burek. Nay: None. Absent: None. Motion passed.

27. Motion by Giszczak, 2<sup>nd</sup> by Tobler to approve the attached resolution to pay off the balance of the General Fund's 30 year loan to the Utility's USDA Fund as read into the record:

WHEREAS, The Augusta Charter Township Board on 12/09/2008 authorized an inter-fund loan in the amount of \$310,941.61 for 30 years at 1% interest from the Utility's USDA MBS Long Term Investment Fund for the purpose of terminating the \$2,300,000 contract with YCUA for the Sewer Reserve Capacity Lease that Augusta Township entered into on the behalf of the Biltmore Developer company for Augusta Farms and Lincoln Farms developments; and

WHEREAS, The Augusta Charter Township Board has reviewed the Township's future projected financial condition and the approved General Fund 2012-2013 Budget has an expected fund balance forward of \$468,301.50 due to the increase in State revenue sharing as an

outcome of the 2010 census with an expected ending budget balance of \$186,158; and

WHEREAS, the Board approved the estimated 2012-2013 budget expenditure of \$281,581 to repay the Utility's USDA Fund;

NOW, THEREFORE, BE IT RESOLVED that Augusta Charter Township Board of Trustees hereby adopts the Resolution to Pay Off the General Fund Loan due to the Utility's USDA Fund in the amount of \$281,581 and authorizing the payment to be processed as a preauthorized post audit warrant effective April 1, 2012 and to be deposited in the Utility's USDA MBS Long Term Investment Fund.
